


August Working Group - Guardianship

The Guardianship Working Group marks our 7th working group since we started in February 2020. The group highlighted the following skills and knowledge areas as key for supporting successful practice:

- Clarification on the Guardianship process (roles and responsibilities, documentation, timelines)
- How to conduct a quality Guardianship assessment
- Practice tips on balancing the need for permanency with the need for strong family connections
- Ways to hear the child's voice when considering Guardianship
