

OOHC Health Pathway e-learning course



Who is this course for?

This free online course has been developed for Department of Communities and Justice (DCJ) and NGO practitioners, including caseworkers to help them implement the OOHC Health Pathway Program. The course has been developed by the DCJ in consultation with NSW Health.

Why was this course developed?

Children and young people in OOHC have increased rates of physical, developmental, emotional and mental health problems compared with their peers in the general community.

Course duration

This course will take approximately one hour to complete, and includes reading the material, quizzes, videos, case studies and reflective activities. It is designed to be undertaken individually, but can also be used as a prompt for discussion between colleagues.

Learning outcomes

By the end of the course participants will be able to:

- ❖ Understand why improving health outcomes for children in care is important.
- ❖ Identify and describe the key steps in the OOHC Health Pathway, who is responsible for undertaking them and by when.
- ❖ Identify their local district OOHC Health Coordinator and describe how to work with them.
- ❖ Identify what needs to be included when completing an OOHC Health Referral Form.
- ❖ Identify the steps that should be undertaken to implement a Health Management Plan in conjunction with key stakeholders.
- ❖ Identify the steps that need to be undertaken to ensure that the child or young person's Health Management Plan is reviewed in accordance with the required schedule.
- ❖ Commit to embedding the OOHC Health Pathway into ongoing casework practice.

Medicare number processes for children and young people entering OOHC
